Historic Wingfield Property in England For Sale - Has Fascinating History

Evidence Indicates Dates to before William the Conqueror

The Wingfield College of Wingfield, Eye, Suffolk, England is being offered for sale.

This is probably the oldest Wingfield property in England. The asking price is £1,250,000 (Approx \$2,275,000 US). The building has two floors, total 5000 sq. ft., 7 bedrooms, 2 bathrooms, great hall, drawing room, library, print room, playroom, study, sitting room, kitchen/breakfast room, cloakroom, formal and informal grounds plus traditional out-buildings with garaging, studio and beau-

tiful grounds. It sits on 9 acres in the village of Wingfield, adjacent to St. Andrews Church and near the Wingfield

Castle. It is believed the present Wingfield College was built on Wingfield owned property going back to, and possibly before 1066. History reveals there were 4 manors in Wingfield, one of which was on the site of the College. The earliest Wingfield at that time was Roger Wingfield who held senior positions in the Royal Household. He was the uncle of Sir John Wingfield III.

Sir John chief counselor and close friend to the Black Prince, married a rich heiress, Alianore (Ellinore) daughter of Sir Gilbert de Glanville. He came into possession of considerable property, plus he received a significant part of the ransom received for the French king captured at the battle of Poitiers in 1356. This affluence provided monies not only for the College, but to upgrade the church and later to build the Wingfield Castle.

With Sir John's sudden death by the plague in 1361, the Black Prince attended the funeral. Sir John Wingfield's will gave instructions that his wife Alianore (Ellinore) and his brother Sir Thomas as executors to build the college and upgrade the church. Henry VIII's uncle was one of three Wingfields at the Field of the Cloth of Gold

The Field of the Cloth of Gold took place in June 1520, near Guisnes which was close to English held Calais on the continent. The jousting and feasting, the color and glitter, the tents and trappings dazzled all of Europe. It was described as a display of medieval chivalry at which King Henry VIII of England crossed the Channel to joust with the new French king, Francis I.

Henry attempted to outdo France both by the splendor of his equipment, the cunning of his diplomacy and even his physical strength.

Attendance included an array of noblemen and a large accompaniment of followers from both countries. Sir Richard Wingfield was English ambassador to France at the time and made all the preliminary contacts with King Francis of France.

There were members of the Wingfield family living in the Calais area, and Henry had several attending him at the Cloth of Gold. They were: Sir Richard Wingfield K. G. (Knight of the Garter), Sir Anthony Wingfield K. G., with his wife Elizabeth Vere, Sir Robert Wingfield K. B. (Knight of the Bath) with

of Richmond, VA are moving to Memphis and feel they can easily make it to the next meeting in Nashville in 2005. At this writing, they plan to go to Ireland this summer to attend a wedding in Dublin then visit Powerscourt in Enniskerry about 40 miles away.

It has just come to our attention that two other WFS members were close and observed first hand the immediate effects of the 9/11 terrorist attack on the World Trade center in 2001. They are **Adam Wingfield Roth** and his wife **Melissa** of New York City, who live about 15 walking minutes distance from what was the World Trade Center. After the fall of the towers, the Roths could not get on their block without ID. Adam remembers, "The whole thing was horrible. There was no traffic allowed below 14th St. (we live about 15 blocks down) so we had to walk everywhere, which isn't bad, but when you walk down the street and there is no traffic, just people on foot, well, it's strange. I walked down the 4th Ave. from 13th St. crying after learning of the deaths of my good friend, and the ten others I had known. A huge man walked up to me, put his hand on my shoulder and said "Let it out." New Yorkers are like that. My job was in advertising. One week later they called me into the office and said none of my clients from Chicago would fly, so they had to let me go. We suffered hard time, but things are just now getting better. You have to enjoy every moment." Other WFS members nearby when the attack happened were **Lance Wingfield** and the **Duchess of York**.

Jocelyn & Sara Wingfield, of Norfolk, England were proud grandparents at the christening at Morston, Norfolk, England on August 1, 2004 of their second grandchild, granddaughter Stella Sophie Burton, daughter of Phil Burton and his wife, Camilla Burton nee Wingfield (who incidentally were living in NYC at the time of 9/11).

IN MEMORIAM

Madeline Spencer Wingfield, age 87, died Saturday, July 3, 2004 in Marrero LA, a native of New Orleans. She was the daughter of the late William M. Spencer and Gladys Dussor Spencer, beloved wife of the late Leo A. Wingfield Sr., mother of WFS member William (Bill) Leo Wingfield and the late Leo A. Wingfield. Mother-in-law of Darlene Hernandez Wingfield. Her grand kids William Spencer, Anne M., Alicia M. and Jessica L. Wingfield also survive her. They are William Spencer and Claire Booth Wingfield. Mrs. Wingfield had been a teacher. Internment at Hope Mausoleum in New Orleans.

On June 29th, 2004 – Robert Winfield of Rockville, MD notified the WFS of the death of **Elizabeth Ann Winfield Randall Collins**, an exceptionally close niece. Following is the message: “Elizabeth Ann is the beloved daughter of Aunt Shirley Ann Henley Winfield and Uncle John Lang Winfield, wife of Edward Collins and Kelly Collins, widow of Gary Randall and mother of Katie Randall, sister of Susan Lang Winfield Gregory, niece of Aunt Dorothy Henley Stone, niece of Samuel Lyle Winfield, niece and namesake of Elizabeth Winfield Powell, niece of Aunt Lenore Isabella Alpaugh Winfield and Uncle Courtland Scott Winfield II, cousin of Courtland Scott Winfield III, Charles Edward Winfield and Robert James Winfield. She was the closest I ever had to a baby sister and whom I grew up with. The sweetest and most gentle loving daughter of her daddy, Uncle John. As beautiful in death as in life to her mother and desperately missed by all in sorrow. She died at age 49, just a baby taken by the evil of cancer.”

Sue Madera of Mabank, TX notified us that her Aunt on her mother's side passed away May 22, 2004 in Kilgore, TX. **Pauline Juia Wingfield** was 92 years old. She was born in Okalona, AR one of 13 children. She was a teacher specializing in mathematics and coached the girl's basketball team. She worked along side her husband and family at Wingfield Builder's Supply in Kilgore, TX for over 54 years.

She was an active member at St. Luke's church in Kilgore and a faithful member of Susanna Wesley Sunday School Class. She is survived by son and daughter-in-law, Jim and Annell Wingfield of Kilgore, TX, a son in law Carl Evans of Columbia, SC, five grandchildren and spouses; four great grandchildren and a host of cousins and other loving family and friends. Her husband, Jimmy Lee Wingfield, daughter Sally Jane Evans, four sisters and eight brothers preceded her in death.

WFS Charter member **Opal West Wingfield**, 86, passed away July 18, 2004 in Eaton, Colorado. She was born on the family ranch in West, New Mexico. Opal graduated from Highlands University in Las Vegas, NM and began her teaching career in a small rural New Mexico village called El Rito.

In 1940 she married her college sweetheart, Edwin E. (Bud) Wingfield. Because Bud was an experienced fireman, he was recruited to the nation's secret Manhattan Project in Los Alamos, New Mexico. The Wingfields were one of the first families to live in Los Alamos and in 1943, they began their family when their first son Charles Barry was born. When Bud enlisted in the navy, the family moved to Santa Fe, NM but returned to Las Alamos upon his discharge in 1946.

Opal began teaching in the local high school in Los Alamos. Her duties included teaching business education and physical education. Her job was predicated on her willingness to also serve as faculty sponsor for the high school yearbook.

By 1954 they had a second son, Wayne and two daughters, Francine and Dea Etta for a total of 4 children.

Opal was a unique woman who balanced her profession allowing time for her family. She was a constantly encouraging the children to excel in their studies, school activities, and the family's interest in raising registered quarter horses. With these horses their children participated in rodeos, explored the mountain trails of New Mexico

and Colorado.

Opal and Bud moved from Los Alamos to Ault, Colorado, in 1984. They had a small farm and raised alfalfa hay, apples, and cherries. This move also provided them the opportunity to travel extensively. With retirement they became active participants in the Wingfield Family Society. This encouraged even more travel as they traced their ancestors throughout the United States, Ireland, Scotland, and England.

Bucking hay bales, weeding a garden nearly an acre in size, and harvesting the fruit from their trees occupied much of Opal's spare time. Once the couple moved into their 8th decade, they decided it was probably time to move to a home with air conditioning, fewer weeds, and no sheep across the road. A house in Eaton, Colorado, was the solution. It accommodated most of their desires. Opal continued to correspond with her many friends, colleagues, and former students.

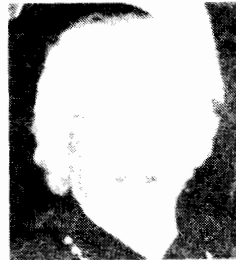
Bud and Opal had been married for 62 years. He died in January of 2002. Opal certainly missed her companion but continued to enjoy life.

Opal West Wingfield was a respected teacher, independent and adventurous woman, and a most loving mother. She was proud of her accomplishments, lavished her children with love, and was the penultimate role model. Opal touched many lives and she will surely be missed.

WFS MEMBER PROFILE:

William Branch Stanton



We are pleased to introduce a fairly new member of the Wingfield Family Society who is also of the Branch family line, William "Bill" Branch Stanton.

He was born in 1953 in Texarkana, AR, the son of William Batte Stanton and Harriet Elizabeth Branch. Bill's father was an orthopedic surgeon and also head of the crippled children's services of the Arkansas Department of Health for many years, now retired. His mother was the family genealogist. Bill has a brother Tom and a sister Gail Stanton McKay. They grew up in Ft. Smith, AR. The three attended the Wingfield meeting in New Orleans in 2003 with their mother.

While still a teenager, Bill was urged to take flying lessons by his father, who was a private pilot and had his own plane. After soloing and one so called "cross country" flight he realized that temperamentally he was not cut out for flying. He gave it up with a meager 30 hours of flight time, confident that the world would be a safer place. During the summer months Bill spent time in his late teens and early 20s working on his father's 100-acre ranch in the Ozarks north of Ft. Smith. He helped the foreman with the cattle, putting up fences, pitching hay and general duties. In high school he showed an interest in writing and was assigned to cover a dam dedication by former president Lyndon Johnson for the school paper. Although he did not get to meet the president, it was a contributing experience that solidified his interest in writing.

Bill has a B.A. in English from Hendrix College in Conway, AR. His

first job out of college in 1975 was with his hometown newspaper the South-west Times Record in Ft. Smith for a couple of months and then with the Arkansas Democrat in Little Rock, both locations as one of several copy editors. He later wrote a sidebar piece on President Gerald Ford's trip to Ft. Smith to dedicate a new hospital.

In 1976 he enrolled at Emory University in Atlanta where he received his M.A. While at Emory he chose to move to Montgomery, Ala for an internship with a group called the Southern Regional Council which had an interesting program monitoring how southern state governments dealt with poverty and racial issues. It was here that he was struck with the desire to work in the field of civil rights. After finishing the program, he decided to stay on in Montgomery.

For ten years (1978-87) Bill worked as investigator at the Southern Poverty Law Center (SPLC) in Montgomery, on death penalty cases before accepting a full time assignment on their Klanwatch Project, first as an investigator and later as its director. Klanwatch monitored activities nationwide uncovering evidence that allowed the SPLC's attorneys to sue organizations and individuals for civil rights violations. Their clients included Vietnamese American and African Americans.

It was also in Montgomery he met Cathy Lee Ansheles who would later become his wife in 1990. She had moved there to do prison reform and anti-death penalty work with the non-profit Alabama Prison Project, after returning from 18 months as a school teacher in Kenya, East Africa. So right off they had something in common.

While employed at the SPLC, writing was part of the job. He wrote for and edited the "Poverty Law Report" of the SPLC and the Klanwatch's "Intelligence Report." In the last decade he has written a number of newspaper op-ed pieces run under his own name or ghost written for someone else. Upon leaving the SPCA, he began writing his own book "Klanwatch: Bringing the Ku Klux Klan to Justice". It was published in 1991.

Cathy had always wanted to live in New Mexico so Bill made a trip to Santa

Fe, to explore the feasibility of working there. A local attorney offered him a job. This led to their move to New Mexico and ultimately to self-employment as a Mitigation Specialist with his own office in Santa Fe. Bill works with individuals facing the death penalty. The goal is not to get "guilty people off," but to try to persuade the jury to return a life sentence instead of the death penalty in capital cases. He does extensive research on the individual's background and looks for an explanation as opposed to an excuse. He is paid by the public defenders department. (Neither Bill nor Cathy is an attorney.)

Cathy now works part time as executive director of the New Mexico Criminal Defense Lawyers Association, a nonprofit organization.

Until this past May, she was also the coordinator of the New Mexico Coalition to Repeal the Death Penalty, a group she helped organize.

Bill's hobbies are photography, music (he plays the flute and is learning the fiddle), travel, jogging and cycling.

Their residence in Santa Fe is a small adobe home with lots of overhead pine beams. With all the wood in the interior it, he says it feels like a cabin. It is situated about 3 miles from the plaza monument marking the spot where the Santa Fe Trail ended. The climate in Santa Fe was a pleasant surprise as it is high desert with a temperate climate.

He belongs to a number of organizations, including: New Mexico Coalition to Repeal the Death Penalty, New Mexico Association of Criminal Defense Lawyers, National Association of Sentencing Advocates, and the Santa Fe chapter of the NAACP.

He has been curious about his family history since as a child his parents would load the whole family into the station wagon and set out on the highways to Georgia, Alabama, South Carolina and Florida visiting his far flung, extended family. These vacations whetted his interest in his family's history as well as Southern history.

Bill does not do family research himself and owes most of the family compiled genealogy, including the Wingfield connection to his mother, the family genealogist. Her research

WINGFIELD FACES FROM THE PAST

William Old Wingfield
b. 1836 d. 1910



William Old lived on the family property in Esmont, Albermarle County, Virginia all of his life. He married Dorothy Minor Childress in 1861. A year later he enlisted in the army to become a sergeant in the 15th Virginia during the War Between the States. He was a Confederate Pensioner and the records show they contributed \$95 toward his funeral in 1910. He is buried in the Mt. Zion United Methodist Church in Esmont.

William and Dorothy had 5 children Lelia Overton, Virginia Ann, James Edlow, Ada Waller and Daisy. Son James Edlow is the father of Mervyn Waller Wingfield, WFS member from Richmond.

William Old's civil war sabre is currently in Mervyn's hands.

In 1947 the old Wingfield estate, including the home in Esmont and 340 acres of timberland was auctioned off.

poses of establishing a secular college.).

There was nothing in the charter about modifying an existing building, but it is believed that the present college was built in 1362 with a major expansion of an existing Wingfield manor (hall-house). There are also indications that parts of this house were still in existence when the college was built in about 1362, on this property according to Rev S. W. H Aldwell in his book, *Wingfield; It's Church, Castle and College, 1925 (republished by the WFS in 1994)*.

It continued as a college for 180 years, until the dissolution of the Monasteries. In 1542 it reverted to the Crown becoming a private house. There is an extensive list of Masters of Wingfield College during this period.

Being carefully and extensively restored in 1971, contributed to it's special architectural and historical interest. Cleverly set behind a Palladian facade from the 1760s, are fascinating medieval interiors with a spectacular partially galleried Medieval Great Hall and a mixture of Tudor and Georgian rooms. At this time Wingfield College, was described by Pevsner as "a handsome house of 1700," before it was discovered to be the original Wingfield College founded in 1362.

The old college represents the origins of education in England and is a reflection of great wealth and power of medieval East Anglia. The site of the old college is of rare historical and archeological interest and is associated with many important and colorful individuals. Wingfield College has received a significant entry in Simon Jenkins' recently published "England's 1000 Best Houses."

In 1971 with just 2.5 acres it was placed for sale and purchased by Ian Chance. It was featured in "Country Life" on January, 7 1982 issue. The former college has been retained as the property and home of Ian Chance who calls it the "Old Wingfield College." and is presently adjacent to the nearby Wingfield Arts Center formed in 1981. All four of the Wingfield tours to England visited the village of Wingfield and were generously permitted inside

the Wingfield College by Ian Chance allowing them to see the Great Hall and some of the ancient examples of construction.

If you believe the Ancient Suffolk Rhyme: "Wynkefeld The Saxon held honor and fee, ere William The Norman came over the sea," you will also believe this was Wingfield property and there before 1066.

De La Pole Arms in Wingfield, up for sale Villagers up in Arms

Ironically, both the Wingfield College and the Wingfield Pub (De La Pole Arms) in the village of Wingfield in Suffolk, England are both for sale. This is strictly a coincidence.

The Wingfield Pub is just a stone's throw away from the Wingfield College and Wingfield Church. Many of our members have seen this in the village of Wingfield on their tour to England. Sadly, most did not have time to go inside. It is now called the De La Pole Arms and was closed down on this past July 4. It is owned by St Peter's Brewery who has operated it for the past 10 years and spent a considerable investment developing the restaurant facility.

According to a pub spokesman, they have been trying unsuccessfully to make a profit and the people of the town have failed to use it and now will lose it. It was reported by a resident that this is a 'loss of our last amenity in the village.' About 200 local residents have signed a petition calling for the pub to be saved, but they fear the district council that has a policy to protect village pubs bid for a change of use.

The selling price is £400,000 (about \$720,00 US) either as a going concern or for conversion to private residence. *(Information provided by Jocelyn Wingfield of Norfolk, England)*

WINGFIELD CHURCHES

Wingfield Church, (Suffolk) England. The present church, St. Andrew's, really began with the foundation of the

adjoining Wingfield College (the Wingfields' ancient Manor house, c.1290s/1300, with its enthralling Great Hall, see headline story), under the 1361 will of Sir John Wingfield, Chief of the peacetime Council of the Black Prince, the heir to the throne (who paid for Sir John's magnificent funeral here). Sir John Wingfield's effigy lies in a



recess in the south wall.

The south porch was built by Michael de la Pole, 1st Earl of Suffolk - who had married Katherine Wingfield, heiress of Sir John. The font was donated by their son, the 2nd Earl. It bears the arms: north - Wingfield, east & west - de la Pole, south - Stafford. The beautiful south-side chancel has delightful Wingfield wings, de la Pole leopards' heads and Stafford knots. Sir John Wingfield's grandson died en route from Wingfield to Agincourt (1415) and his son, William de la Pole rebuilt the chancel in his father's memory.

In 1995 the Wingfield Family Society (WFS) presented a cheque for \$1,500 towards the major refurbishment at the church. For recognition there are three WFS clerestory windows, all so marked: one funded by Lois Wingfield Wickham in memory of her brother, Dr. Bill Wingfield of Ashland, Virginia, co-founder of the WFS; one funded by Dr. James R. & Susan Wingfield of Illinois and the other funded by all members of the WFS. The Wingfield vestry of this tiny village of about 200 souls - mainly retired agricultural workers - has in its 20-year restoration program (1984-2004) already raised \$658,000, and, as at July 1, 2003, is still \$37,500 short for repairing the roof of this magnificent church.

wife Jane Clinton. Two of these were brothers and one was a nephew. Sir Richard's wife did not attend the ceremony. The three Wingfields were descendants of Sir John of Letheringham and his wife Elizabeth, daughter of Sir John Lewis of Essex.

Sir Richard Wingfield, K. G. was of Kimbolton Castle and married to Catherine, youngest daughter of Richard, Earl of Rivers, and sister of Elizabeth, wife of King Edward IV making Henry VIII, by marriage, a nephew of Sir Richard Wingfield.

Sir Richard had been made Marshal of the town of Marches (surrounding country) of Calais together with his brother Robert. This appointment was to carry on with whichever lived the longest.

At the Field of the Cloth of Gold, Henry suddenly challenged Francis to a wrestling match. Francis seized Henry in a lightning grip and threw him to ground. Henry went white with embarrassment, but held back his temper. The ceremonies continued, but Henry could not forgive such a personal humiliation. Any chance for cooperative friendship dissipated with the incident. Indeed, Henry had already begun negotiations with Francis's enemy (Holy Roman) Emperor Charles V. Within a month, Charles declared war on France, thus forfeiting any French tribute.

Not only was the Field of Cloth of Gold expensive, but Henry further squandered feverishly on an expedition to Boulogne and subsidies to mercenary contingents serving with the Emperor.

Jamestown 2007 Celebration Brings another event to Virginia

With a stream of tourists expected in 2007, for anniversary of the founding of Jamestown, another museum is being built to take advantage of these visitors. It is the Tredegar National Civil War center in Richmond. The museum is being built by the Tredegar Iron Works, the ironworks of the confederacy in Richmond. They feel the Civil War was a part of our country's history, as was the founding of Jamestown, so why not coincide their museum with the Jamestown celebration.

U. S. Postage Stamp Honors John Wayne, Friend of Ralph Wingfield

This past September, the U. S. Postal Service released a 37 cent stamp in the name of one of Hollywood's legends, John "Duke" Wayne.

When you see this stamp on letters, just remember John Wayne and Ralph Wingfield, the Nogales, Arizona rancher were long time friends

"The Duke" & Ralph Wingfield, a former member of the WFS, became acquainted in the 1940s. In 1948 Ralph lent some of his cattle for the use in the movie "Red River". Wayne and Ralph became good friends and was known to be a frequent visitor at Ralph's Guevavi Ranch over the years and they even owned property together in Arizona in 1969. Wayne furthered this friendship by taking Ralph on several voyages on his yacht.

Mr. Wayne died in 1979 and Ralph Wingfield on March 15, 2001. (For more information on Ralph Wingfield, see his Member Profile 1997, Vol II, No. 4 issue of the WFS newsletter.)



Restored Confederate Chapel built by a Wingfield

For Civil War buffs who wish to deepen their appreciation of post war Virginia should visit the Confederate War Memorial (Pelham) Chapel in Richmond. Completed in 1887 it was built by **Joseph F. Wingfield**. It was originally part of a complex of a home for Confederate Veterans. Most of the original buildings were torn down in the 1930s. Today only three of the original remain on the grounds, of which the Pelham Chapel is one.

During the Civil War Centennial of 1960, over \$40,000 was raised from private donations for restoration of the Chapel. Today it is know as a Virginia Historic Landmark and is controlled by the Virginia Museum of Fine Arts. (Information Pelham Chapel supplied by Chris Wingfield of Newport News, VA.)

Wingfields in Sport

There was a Ted Wingfield and Dave Winfield who became professional baseball players in the United States.

Ted's full name was **Frederick Davis Wingfield**. He was born in Bedford, VA August 7, 1899, debuted as a player September 23, 1923, died July 18, 1975 in Johnson City, TN.

Dave's Winfield's is **David Mark Winfield**, born October 3, 1951 in St. Paul, MN, debuted on June 19, 1973 and was secured by the San Diego Padres the same year in an amateur draft. Dave was inducted into the Baseball Hall of Fame in 2001. (Source WFS home page under Wingfield Links.)

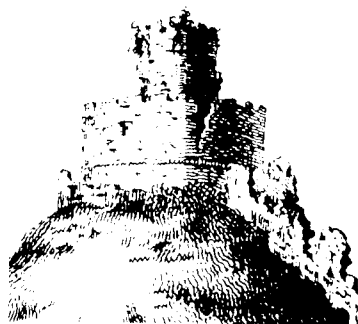

CASTLE CONNECTIONS

Launceston Castle, Cornwall

Originally built in the days of William the Conqueror by Count of Mortain, this castle (shown in a 1749 sketch by Borlase) stood as part of Cornwall's only walled town. In August 1354, Sir John Wingfield joined with the Black Prince here. By September 2nd Sir John had to move on, 20 miles to the southwest to Restormel Castle, since he and Sir Richard de Stafford and Sir William de Shawshull (?Shareshall) were sitting as King's Justices at nearby Lostwithiel. George Fox, founder of the Society of Friends ("Quakers") in 1647, was



imprisoned here. He preached widely in England and, after 1671, in the West Indies, North America and the Netherlands

Jocelyn Wingfield's Books go to Library in England

According to a news release in July, 2004 by the New World Tapestry and Library, Jocelyn Wingfield will be recognized as an Adventurer (supporter for the Tapestry) for donating his personal 200 book library to the British Empire and Commonwealth Museum in Bristol, England. The Tapestry and Museum have a cooperative agreement.

Jocelyn generously presented 95% of his collection, on August 3rd, with

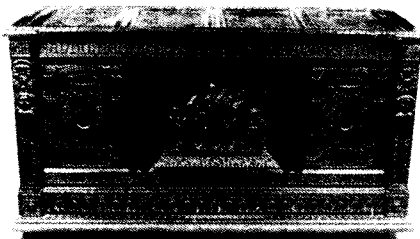
the balance to be received at his demise. Each book will have inside sticker recognition identification showing Jocelyn Wingfield as donor. They went into America's section of the library of the Museum in time for their Pow Wow program opening in September where it will also permanently display the New World Tapestry with 24 panels including the one on Jamestown. It was presented there by Tom Mor the Tapestry's owner on September 15th. There were storytelling sessions, formal workshops, native North American Indian workshops and shows. Jocelyn was expected to be invited to lecture to an adult audience on Edward-Maria Wingfield's role at Jamestown during the Pow Wow.

Lloyd-Wingfield 1640 Oak Chest Reappears, Sold

In March, 2004 one of the bigger of Bonham's "Sales of house contents" in England's East Anglia (at the Old Rectory, Banningham Norfolk) offered a very fine, magnificently carved, oak *coffer* (3 ft. 6 in. high by 6 ft. long) of 1640. The two central foliate scroll panels of four on the lid have the arms of Lloyd impaling Wingfield. The front central panel depicts the Nativity. The chest's value estimate was \$1100-1600, but it went for just over \$5100. Sadly, the Onslow Wingfield bid failed.

The chest was apparently pre-

sented to Shrewsbury Abbey Church by Councillor Thomas Lloyd of Shrewsbury, Shropshire, husband of Rebecca Wingfield. Thomas Lloyd served on the Council of Rebecca's half-brother, Thomas Wingfield II, who was elected Mayor of Shrewsbury to complete the last part of that very year of 1640. Thomas Lloyd died on 16th June 1647 and his grand tomb with its bright Lloyd

and Wingfield arms can be seen in Shrewsbury Abbey today. (See www.wingfield.org under "Churches", then "Shrewsbury"). Such *coffers* (i.e. chests) were used as "Communion or Record Chests". Sometime later - according to an old undated cutting now glued in the chest - this great family heirloom turned up in a farmhouse in Bridgenorth, a town 18 miles to the southeast of Shrewsbury, before coming to Banningham.

In 1630, i.e. ten years before the chest was made (and fifty years before the above Thomas Wingfield's namesake, Thomas Wingfield of St. Benet's, London, was to be described as "of York River, Virginia"), Thomas Wingfield II of the Shropshire Line was one of a group of financial backers of the development of New Hampshire - especially in or near Stratham. .
